BLOCK SEMINAR CONTROVERSIES IN DEVELOPMENT ECONOMICS

Course description

This seminar addresses controversial issues in development economics. The seminar aims at providing a comprehensive overview of fiercely debated issues in development economics. The seminar paper will be written together by the two students assigned to the same topic and will provide a balanced stance towards a specific controversy. Based on the paper, students will prepare a 10 minutes presentation/statement that assumes a one-sided position during the seminar. There will be two presentations for each controversy. Moderated discussions between the two positions will be preceded and followed by a vote of the entire group to assess how convincing the respective presenter has made his or her argument. Active class participation matters a lot for overall quality of seminar.

Eligible participants

Students enrolled in the MA program "Development Economics and International Studies". Maximum number of participants: 20

Seminar paper

Two students will be assigned to each topic. Students assigned to the same topic will write the seminar paper together and provide a balanced stance towards the specific controversy. The paper must not exceed 20 pages, excluding Tables and Figures. The authorship of each section must be indicated in the Table of Contents. The introduction and conclusion must be written together. The paper ought to be written in English, using Times New Roman (12 points) or Arial, Calibri or Cambria (11 points). Line spacing 1.5, margins: left 2.3 cm, right 4 cm, top/botton: 3 cm. Please include page numbers (numbering should start with "1" on the first page of maintext).

A comprehensive search of the relevant literature and a critical survey of it are of great importance for the quality of the paper. The literature suggestions for each topic are just the starting point for a more comprehensive literature search.

Students should hand in an electronic (pdf, to: Sebastian.prediger@kfw.de, including topic number) as well as one printed copy of their seminar papers (in the secretary's office, Ms. Lohmaier, Kochstraße 4). The electronic version will then be made available to all other students for reading.

Deadline is April 30, 2 pm.

Presentation and Discussion

We will have two presentations on each topic. Before the presentation, the "audience" will vote on the controversial issues (for example, "Do you think that states should play a more active role in promoting economic development than they currently do?"). In the presentations, each presenter will then take one of the possible views on the issue and make an attempt to convince fellow students of that view. The students will be facing the audience and seated in front of their fellow students as in a panel discussion format. The speakers can use any visual device for their presentations (e.g. handouts, transparencies). Note that the one-sided view will only be required in the presentation. The seminar paper must be more balanced.

After the presentations the audience can ask questions and let the presenters defend their positions, before there is another vote on the same issue. It is expected that all other students have briefly gone through the papers of the other participants before the seminar, so that a good discussion after the presentations can take place.
